



There was a decrease in most activity in March 2024 compared to the prior year. There was a sizeable increase in extortion/forgery/scam/fraud/ID Theft reports for the month of March and year to date, the majority of these were online scams. There were decreases in theft and criminal mischief reports during March. Also, traffic stops were down 42.9%, calls for service were down 1.8%, arrests were down 41.2%, and the number of charges were down 41.3%. Reports written were down 12.8% and outreach events were down 26.8%.

The following chart represents March Computer Aided Dispatch events with a mental health aspect from 2020–2024.



There were five OWI incident counts during the month of March 2024. Testing was refused in one of the cases. In the remaining cases, the Datamaster BAC ranged from .069 to .179, with the average Datamaster BAC being .109. During March of 2023 there were fifteen OWI incident counts. Testing was refused in three incidents, testing was unable to be done in one incident with a search warrant for a blood draw served, and drugs were involved in two other incidents with urine samples collected (including one incident where the Datamaster BAC was .074). In the remaining cases, the Datamaster BAC ranged from .096 to .281, with the average Datamaster BAC being .144.

There were three public intoxication reports during March 2024. Testing was refused in one incident and unable to be done in another. The BAC in the other incident was .194. There were four public intoxication reports for the month of March 2023. Testing was refused in one of the reports. In the remaining reports the BAC ranged from .076 to .226, and the average BAC was .191.

During the first quarter of 2024, there were two incidents requiring response to resistance (use of force), 95 arrests, and 8,178 calls for service. Response to resistance incidents represent 2.1% of arrests and 0.02% of calls for service during this time.
